## JobKeeper Top-Up's - IMPORTANT

### Fortnight # 3 JobKeeper Payment Deadline - Sunday 10 May 2020

For those businesses who have enrolled in the JobKeeper Scheme, it is imperative that you maintain the minimum fortnightly gross payment of \$1,500 to all enrolled employees.

Please see the timeline below for minimum payments as per the ATO JobKeeper specified fortnights **PER ENROLLED ELIGIBLE EMPLOYEE:**
