- 2. You cannot get Centrelink's "JobSeeker" and this new "JobKeeper" at the same time.
- 3. This is a much better system than sending millions onto the payroll at Centrelink, per Stimulus Package 2. It may create some confusion, but ultimately will work a lot better.
 - We are having many enquiries for assistance, so please be patient with us. The important point is that rushing will make no difference.
